RESPONSIBILITIES:

Annual giving societies:

Champions Society, benefiting Prisma Health Children's Hospital—Midlands
Atrium Society/The Cavalry, benefiting Prisma Health Cancer Institute—Columbia

- · Leads the strategy for member cultivation, stewardship and growth of the societies
- · Engages members and identifies prospects
- · Works with volunteer leadership committees to meet fundraising objectives
- · Organizes and leads member and prospect connection events
- · Engages with leadership of Children's Hospital—Midlands and the Cancer Institute—Columbia for educational components, connection points and service line information
- · Works closely with Major Gifts officers and Foundation leadership to identify and cultivate annual giving donors and support the donor continuum
- · Develops and manages budgets for annual giving societies

Miracle Team annual giving for internal team members:

Prisma Health Midlands Foundation engages Prisma Health—Midlands team members (avg. of 15,000 in the Midlands) annually, to ask for their support through Miracle Team. Midlands Foundation efforts are part of a systemwide approach to team member annual giving.

- · Oversees and leads the Midlands Foundation's Miracle Team annual giving strategy
- · Engages Prisma Health—Midlands team members through the Miracle Team campaign, in collaboration with other Prisma Health foundations and Office of Philanthropy
- · Develops and manages the Miracle Team budget

POSITION REQUIREMENTS:

- · Bachelor's degree and 7+ years of experience in fundraising, annual giving, health care philanthropy, nonprofit or related area of work
- · Strong written, presentation, verbal, organizational and interpersonal skills
- · Demonstration of good judgement, professionalism and the highest standards of ethical conduct
- · Proficiency in Microsoft Office (Word, Excel, Teams, Outlook)
- · Familiarity and/or direct experience with The Raiser's Edge by Blackbaud

Candidates must meet the following additional requirements to be considered for the position:

- · Satisfactory outcome of a personal background check to include professional references, verification of previous employment and education, criminal background check and driving record.
- · Must possess a state issued, valid driver's license.
- · Must possess original social security card or passport (copies will not be accepted).
- · Must have a vehicle and provide proof of auto insurance coverage.
- · Must be willing to sign a Non-Compete Agreement, Confidentiality Agreement and Conflict of Interest Statement.

- · Must provide proof of recent Influenza Vaccination (or Exemption) or willingness to receive the vaccine if hired and on an annual basis.
- · Must provide proof of COVID-19 Vaccinations (or Exemption) or willingness to receive the vaccines if hired.
